Dates to Remember:

April 15 - Registration deadline, send entry form along with check for booth fees. (Photographs are encouraged but not required.)

May 15 - Setup 7 - 9 a.m.

Eligibility - Open to any craftsperson, artists, 18 years or older. All work displayed must be for sale with prices clearly marked. Craftpersons/artist whose work is accepted must be present for the duration of the show to sell his/her work and meet the public. No applicant will be excluded from participation in events sponsored by the HAC on the grounds of race, color, or national origin, disability, etc.

Media - All arts and crafts are eligible including painting, printmaking, photography, pottery, jewelry, etc. Items should be original design and hand crafted. The event committee reserves the right to remove any item it feels inappropriate.

Application - Registration form must be complete and mailed along with fee in order to reserve a booth. Photographs or slides of work are encouraged but not required which helps to promote the event. Listing of all type of work for sale should be included. HAC reserves the right to reproduce photos/slides for promotional purposes.

Fees - Booth fees must accompany entry form. No refunds for cancellation. A 10' x 12' space is \$50. No electricity available.

Set-Up - Exhibitors are responsible for their own displays including tables. Tables are required to be skirted to the ground on the front and sides with appropriate material (color of your choice.) See calendar for setup time. Note: There is no set-up allowed during show hours. Exhibitors may not leave before show is over at 4 p.m.

Sales - All sales are handled by exhibitor. HAC collects no commission on sales. Taxes are the sole responsibility of the exhibitor.

Security - Security will not be provided. All craftspeople exhibit work at their own risk. It is understood that HAC does not carry insurance to cover your personal property. As an independent contractor, you are advised to obtain your own insurance.

Liability- Each exhibitor is responsible for the safety of his/her own display. It is understood that neither the board/staff of HAC or the City of Hendersonville are to be held liable for any damage, theft, or loss of property, nor for injury to exhibitors or loss or injury caused by products sold or exhibited by participants of the show, directly or through warranty expressed or implied.

Insurance for such loss, damages, or injury shall be the sole responsibility of each exhibitor at their own cost. The above named shall not be held liable for failure to produce or continue the show if such failures are brought about by causes beyond their control. Your signature on the entry form indicates an agreement to hereby and forever discharge HAC, its employees, representatives, and the City of Hendersonville from all matters of actions, suits, damages, claims and demands whatsoever in law or equity from any loss or damage to the assignee's property or person while in possession, supervision or auspices of HAC and City of Hendersonville.
